Sl. No.	The school is directed to ensure that:
1	The total number of sections for Bal Vatika is restricted to 03 (01 each for Bal Vatika I,II & III respectively). Further, the total number of sections for classes 1st to 10th shall be restricted to 12 only. The optimum number of the students shall be restricted to 40 in each section. Any further increase of sections shall be subject to specific approval of the Board on the basis of the request of the school as per affiliation bye law and availability of class rooms of 500 sq ft and greater in dimension.
2	The boundary wall of the school covering the campus is still under construction and lesser than the appropriate height (preferably 6 ft) raising the safety concern for the students and the staff. School should be covered with appropriate height of concrete boundary wall as per the Affiliation bye laws. School is directed to construct the boundary wall with appropriate height from all sides and upload the compliance with videography on SARAS portal within 03 months.
3	The computer lab is under stocked whereas school should have a minimum of 40 computer norms with well net connectivity and other recommended infrastructure as per the Board guidelines and SoPs notified vide circular No. 11/2022. School should

	upgrade the computer lab and upload the compliance with videography on SARAS portal within 03 months.
4	The composite science lab needs to be upgraded and arranged with all safety measures and recommended infrastructure as per the Board guidelines and SoPs notified vide circular No. 11/2022. There are no exhaust fans, fire extinguishers and safety manual for users in the lab. Further, the chemicals and instruments are seen in open cabinet raising safety concern. School is directed to arrange the lab as per the Board guidelines and upload the compliance with videography on SARAS portal within 03 months.
5	The math lab is temporary and a makeshift arrangement by adjoining the small racks with few instruments/charts/models. There are no proper workstations, stock and seating arrangement for the students. School is directed to follow the Board guidelines and arrange the lab as per the notified SoPs vide circular No. 11/2022 and upload the compliance with videography on SARAS portal within 03 months.
6	The CwSN toilets separately for boys and girls are not seen in the inspection videography. The school should have CwSn facilities in compliance of the statutory provisions of the RPwD Act and the circular No. 05/2023 of the Board. School is direction to arrange for the CwSN facilities and infrastructure including ramp for wheelchair bound person as per the Board guidelines and upload the compliance with videography on SARAS portal within 03 months.
7	School has not constituted the POCSO and Sexual Harassment committees as per the statutory provisions. The male staff have been appointed for the committees which is in violation of statutory norms. School is directed to re-constitute the committee as per norms and upload the compliance within 03months on SARAS portal.
8	The school is directed to run the foundation classes/ bal-vatika I, II & III in accordance with established norms permitted vide Board's circular no. 12/2023 dated 24-03-2023 & 25/2023 dated 11-09-2023.
9	School shall ensure the mandatory training of its teachers from the CoE, CBSE Chandigarh and shall upload the compliance within 03 months on SARAS portal.

Compliance of the above mentioned points shall be submitted within 03 months on the SARAS Portal. Failure to comply within the prescribed time shall invite financial penalty @ Rs. 50,000/- every month until compliance is submitted and shall debar the school from filling the registration and LOC of students class IX to class XII, as the case may be.

The approval of the Board as mentioned above, is subject to the following conditions:-

- 1. The school shall be responsible for its genuineness of the documents/ data/ information uploaded by the school. In case of any discrepancies, action will be initiated against the school as per Affiliation Bye -Laws-2018.
- 2. The school shall follow the RTE Act, 2009 and instructions issued thereon by the CBSE/Respective State /UT Govt. from time to time. The school will also abide by the conditions prescribed, if any, by the State Government concerned.
- 3. The School shall apply online for extension of affiliation along with the requisite fee and other documents as per Rule 10.3 of Affiliation Bye Laws.
- 4. The school shall go through the provision of Affiliation and Examination Bye Laws and subsequent amendment therein as well as circulars and guidelines /instructions issued by the Board time to time and keep a copy thereof for reference purpose and is also advised to regularly visit CBSE websites i.e., http://cbseacademic.nic.in/ & http://cbse.nic.in/ for updates.
- 5. The school shall renew mandatory certificates from time to time.
- 6. The school shall be solely responsible for any legal consequences arising out of the use of school name/logo/society/trust or any other identity /activity related to running of school affiliated to CBSE. All legal expenses incurred by the Board, if any, arising out of these circumstances, shall be borne by the school.
